APPEAL FROM ORDER RELATING TO GROUP-VI CONCERNING SERVICE OF THE JUDICIAL OFFICERS, OFFICERS AND STAFF OF HIGH COURT SERVICE AND DISTRICT JUDICIARY [BOTH RETIRED AND SERVING] AND APPLICATIONS CONNECTED THERETO;

APPEAL FROM ORDER RELATING TO POLICE UNDER RESIDUARY (GROUP-IX) INCLUDING APPLICATIONS CONNECTED THERETO;

ANY OTHER MATTER, IRRESPECTIVE OF CLASSIFICATION, AS DIRECTED BY HON'BLE CHIEF JUSTICE.

NOTE:

I. ON EVERY MONDAY, PIL (MOTION) MATTERS WILL BE TAKEN UP FIRST. THEREAFTER, WP.CT, GROUP-VI, GROUP-IX MATTERS WILL BE TAKEN UP SERIALLY, IF TIME PERMITS.

II. ON EVERY TUESDAY, WP.CT (MOTION) MATTERS WILL BE TAKEN UP FIRST. THEREAFTER, GROUP-VI, GROUP-IX, PIL MATTERS WILL BE TAKEN UP SERIALLY, IF TIME PERMITS.

III. ON EVERY WEDNESDAY, GROUP - VI (MOTION) MATTERS WILL BE TAKEN UP FIRST. THEREAFTER, GROUP-IX, PIL, WP.CT MATTERS WILL BE TAKEN UP SERIALLY, IF TIME PERMITS.

IV. ON EVERY THURSDAY, GROUP-IX (MOTION) MATTERS WILL BE TAKEN UP FIRST. THEREAFTER, PIL, WP.CT, GROUP-VI MATTERS WILL BE TAKEN UP SEIRALLY, IF TIME PERMITS.

V. ON EVERY FRIDAY, ASSIGNED MATTERS AND APPLICATION, IF ANY WILL BE TAKEN UP FIRST. THEREAFTER, PIL, WP.CT, GROUP-VI, GROUP-IX MATTERS WILL BE TAKEN UP SERIALLY, IF TIME PERMITS.

VI. EVERYDAY HEARING MATTERS WILL BE TAKEN UP AT 2 PM OR IMMEDIATELY AFTER COMPLETION OF THE MOTION MATTERS, WHICHEVER IS EARLIER. AFTER COMPLETION OF THE HEARING MATTERS, MOTION MATTERS WILL BE TAKEN UP SERIALLY, IF TIME PERMITS.

VII. ON EVERY FRIDAY, ORIGINAL SIDE MATTERS WILL BE TAKEN UP FIRST. AFTER COMPLETION OF THE ORIGINAL SIDE MATTERS APPELLATE SIDE MATTERS WILL BE TAKEN UP SERIALLY.

VIII. LD. ADVOCATES FOR THE PARTIES ARE REQUESTED TO FILE THEIR LAW NOTES IN ALL HEARING MATTERS.

IX. MENTIONING WILL BE ALLOWED AT THE FIRST SITTING OF THE COURT ONLY ON MONDAY UPON NOTICE TO THE OTHER SIDE(S).

X. FINAL HEARING MATTERS ORDINARILY SHALL NOT BE ADJOURNED.
