court. Trial of suits by witness examination shall be suspended. Other

proceedings in suits to continue.

• Staff attendance shall not be more than 66 & 2/3 percent with rotational

transferable duty. Non essential departments may be suspended and their

staff shall be utilised in essential departments.

• The same system shall be followed in the District Courts as far as applicable

and practicable.

• The same system shall be followed in the Circuit Benches subject to

adaptation by the Senior most Hon'ble Judge in Circuit.

• The concerned stakeholders including Court-staff shall get themselves fully

vaccinated and shall strictly adhere to the norms of social-distancing and
