Concerned candidates will have to bring the Admit Card of the Written Examination held on 25.03.2018 issued by the Chairman, District Recruitment Committee, Dakshin Dinajpur Judgeship along with other documents to appear in the Personality Test (Interview).
- **2.** Candidates are required to bring the following documents in Original along with one self-attested photocopy of each and produce the same at the time of reporting to the Authority on the day of Personality Test (Interview):
 - (i) Admit Card of the Written Examination held on 25.03.2018 issued by the Chairman, District Recruitment Committee, Dakshin Dinajpur Judgeship.
 - (ii) **Age Proof:** Class-VIII pass / School-leaving Certificate or Admit Card of Madhyamik or equivalent Examination issued by competent authority.
 - (iii) **Proof of Identity:** Passport or PAN Card or AADHAAR Card or EPIC (Voter Identity Card) or Driving Licence.
 - (iv) **Proof of Residence:** Passport or AADHAAR Card or EPIC (Voter Identity Card) or Driving Licence.
 - (v) All the Mark-sheets and Certificates upto his highest educational qualification (if applicable).
 - (vi) 02 (TWO) copies of recent passport-size coloured photograph, preferably the one used while filling the Online Application Form.
 - (vii) **Caste Certificate** for the candidates belonging to Scheduled Caste/ Scheduled Tribe/ Other Backward Classes.
 - (viii) **Discharge Certificate** for the candidates belonging to Ex-Serviceman category.
 - (ix) **Exempted Category Certificate** for the candidates belonging to Exempted Category.

- **3.** Candidates must report at the Venue at the time mentioned to get their documents verified by the Authority.
- **4.** Admission to the Personality Test (Interview) is purely provisional subject to determination of eligibility in terms of the advertisement.
