REVISED MERIT WISE RESULT FOR PROMOTION TO FAST TRACK COURT 2024

The Revised Merit list of the selection process for promotion to Fast Track Courts for the year 2024 from the substantive cadre of Civil Judge (Senior Division) of the West Bengal Judicial Service.

The first 28 (twenty eight) Officers of this Merit-wise list (from Sri Souvik De to Sri Gautam Kumar Nag) had already been recommended for promotion to the post of Additional District & Sessions Judge, Fast Track Court, vide Court's Notification No. 1095-R(JS) dated 17.02.2025 keeping one vacancy reserved towards filling up of 29 (twenty nine) vacancies declared vide Court's notification no. 6738-R (JS) dated 31.07.2024 read with 6825-R(JS) dated 02.08.2024 for the year 2024.

Smt. Leena Sharma (29th rank of the revised merit list) is further recommended for promotion to the post of Additional District & Sessions Judge, Fast Track Court in terms of the resolution of the Administrative Committee Meeting dated 07.08.2025 against one vacancy kept reserved.

Smt. Anamitra Bhattacharya is not found suitable for promotion to the post of Additional District & Sessions Judge, Fast Track Court for the year 2024 in terms of the resolution of the Administrative Committee Meeting dated 07.08.2025 on account of Disciplinary Proceeding initiated against her vide resolution of the Administrative Committee Meeting dated 06.02.2025 and memos thereof.

Mere empanelment, however, shall not create any right whatsoever in favour of the officers appearing in the merit list for getting promotion.
