**REVISED MERIT WISE RESULT OF PROMOTION TO CIVIL JUDGE (SENIOR DIVISION)/CJM - 2024**

The Revised Merit List of the selection process for promotion to the cadre of Civil Judge (Senior Division)/CJM from amongst the eligible officers in the cadre of Civil Judge (Junior Division)/Judicial Magistrate of the West Bengal Judicial Service for the year 2024

The first 32 (thirty two) Officers from this Merit List (From Ms. Arshia Mustaque to Smt. Stotri Saha) had already been recommended for promotion in the cadre of Civil Judge (Senior Division) vide Court's Notification No. 2895-RG dated 16.04.2025, keeping one vacancy reserved towards filling up of 33 vacancies mentioned in the Court's Notification No. 6746-R(JS) dated 31.07.2024 for the year 2024. Smt. Tamali Ghosh ranked 33<sup>rd</sup> of this revised merit list is further recommended for promotion to the cadre of Civil Judge (Senior Division) against one vacancy kept reserved in terms of the Resolution of the Administrative Committee Meeting dated 07.08.2025.

Sk. Mohammed Arif Hasan is not found suitable for promotion to the cadre of Civil Judge (Senior Division) for the year 2024 in terms of the Resolution of the Administrative Committee Meeting dated 07.08.2025 on account of Disciplinary Proceedings initiated against him vide Resolution of the Administrative Committee Meeting dated 04.01.2024.

Mere empanelment, however, shall not create any right whatsoever in favour of the officers appearing in the merit list for getting promotion.
