- 2. Quotations should be submitted in sealed envelope with C.A.G/Web/1379/25 Dated 31.07.2025 Superscripted in it.
- 3. Rates should be quoted indicating price/unit and should be inclusive of all additional taxes/charges.
- 4. Willing suppliers submitting Quotations should know that the Hon'ble Court may procure such quantity of listed article\_as it may consider necessary, and that, supply of article is to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Original Side Establishment of the Hon'ble Court as per instruction of the Deputy Registrar (Administration-in-Charge), High Court, O.S. Calcutta.
