- 3. Rates should be quoted indicating price / unit and should be inclusive of all additional taxes/charges.
- Willing suppliers submitting Quotations should know that the Hon'ble Court may procure such quantity of listed articles as it may consider necessary, and that, supply of articles is to be made within such date as the Hon'ble Court may consider convenient and to the different sections / offices of Appellate Side Establishment of the Hon'ble Court as per instruction of the Deputy Registrar (Court Management), High Court, A.S. Calcutta.
- Suppliers are instructed to mention PAN no. in the quotation and copies of trade license and / or PAN etc is to be submitted as and when the D. R. (Court Management), High Court, A. S., Calcutta may direct.
