No quotation even 'if complete, irrespective of whether hand-delivered or sent by Post etc., will be received after 14-00 hours of 05.08.2019.

## **B. OPENING OF QUOTATION:**

1. Quotation, if considered valid and complete, will be opened jointly by Ld. Registrar, Circuit Bench of Calcutta High Court at Jalpaiguri, Deputy Registrar and drawing & Disbursing Officer, Circuit Bench at Jalpaiguri and any subsequent declaration pertaining to the instant '**Notice**' will be published in the same 'Notice Board of the Circuit Bench'.
