2. Rates should be quoted taking into account the description, make, type, specification and quantity of all articles required to build the network for which quotations have been invited.
3. **Rates quoted should be inclusive of all applicable charges, taxes, duties and levies.**
4. Conditional quotations will not be considered.
5. Willing vendors cum service providers submitting quotations should specify the address of its office and its phone/mobile number (and other contact numbers e.g. Fax, e-mail if available) for the purpose of quick communication in the event of urgency.
